


# Bolesworth Public Consultation

### **Submission method:**




## Respondents' relationship to Tattenhall

92% of respondents were residents.




## Age profile of respondents.

## Two thirds of respondents believe there is a housing shortage in Tattenhall.



*\*Anyone who identified a type of housing shortage has been deemed as having answered yes to the existence of a housing shortage in Tattenhall.*




**Of those reporting housing shortages, starter homes were considered in shortest supply, followed by affordable housing and downsizer properties.**

## Open spaces and sport facilities are deemed of high importance.



**Question 2:** Rate the following amenities in levels of importance to you.

46% of respondents say Barbour Square would be the best location for a new surgery.**


**Question 3:** Local health bodies have identified that Tattenhall's GP surgery is currently over capacity and limited by its existing site. If changes were possible, which location do you believe would be most suitable for a GP surgery in Tattenhall?

**Respondents stated that there is significant congestion in the centre of the village, whilst Frog Lane and Rocky Lane are less congested.**



**80% of respondents stated that they are very concerned about flooding and that reducing flood risk should be a key consideration in decision making about development in the village.**

**Question 6:** How concerned are you about the risk of flooding in Tattenhall?

- Not at all concerned – the village has bigger, other priorities
- Somewhat concerned – occasional flooding is an unavoidable part of life and should have limited consideration in village planning
- Very concerned – reducing flood risk should be a key consideration in decision-making about development in the village
